SET4BIO is a Horizon 2020 project to support the execution of the Implementation Plan of SET Plan Action 8 - Renewable Fuels and Bioenergy.



#### MAPPING R&D BIOENERGY PROJECTS IN MEMBER STATES

SET4BIO partners are conducting a thorough survey of currently ongoing or recently finished bioenergy projects. So far, the survey has mapped out:

204 projects funded at National level in 10 countries; 41 collaborative EU projects, funded mainly through Horizon 2020.




#### PRELIMINARY ANALYSIS OF AVAILABLE PUBLIC FUNDING TOOLS





## INSTITUTIONAL FUNDING OPPORTUNITIES

SET4BIO also outlined a review of institutional funding opportunities for medium-high TRL level.

Funding range per project varies generally from € 3 millions (mainly for lower TRL levels) to over € 15 millions.

Funding conditions mainly include grants, loans and equity. Additional conditions provide for co-funding by member states, EU and different stakeholders.
